About offender rehabilitation facilities

Incident

- •102 facilities nationwide (as of Aug. 2023)
- Private-sector facilities
- Operated on a consignment basis by the probation office (national government)
- Offender rehabilitation facilities are operated with public-private collaboration
- = Purpose is to improve and rehabilitate criminals and delinquents, prevent recidivism, and reintegrate these people into society



Subjects (users)

- Juveniles released from juvenile detention center
- People who have been paroled from prison
- People who have been released from prison
- People given a suspended sentence
- People whose prosecution has been suspended
- Others

An intermediate facility for those who have no place to return to, in order to prepare them for return to independent life.





Characteristics of Jiaikai

- Focus on male adults
- Capacity: 15 persons (13 adults, 2 juveniles)
- Average length of stay: 70 days
- Nature of misconduct/crime: Violation of the Stimulants Control Act, theft, etc.
- Facilities designated to accept <u>persons eligible for special treatment</u>
 - (elderly, persons with physical, intellectual or mental disabilities, etc.)
- Six staff members: Facility director, supervisor, assistants, welfare staff







Content of practical training





Meet and talk with users

Seek to eliminate fears and prejudices, and understand the user's desire to change, but not being able to change

Visits and lectures by related organizations

Think about what is required by society and what is needed of society

Courts, Prosecutor's Office, detention facilities, classification office, youth detention center, prison, probation office, hospital, self-help groups, employment office, social welfare associations, etc.

Interview and assessment

Understand the user's difficulties in life and examine one's own feelings.

Compile support plan

Nurture perspectives and responsibilities as a social worker

Important things to consider when providing practical training

1 Talk with users

Get to know the background of the incident, recognize that the person requires social welfare, and consider the possibility of support.

2 Notice any sense of discomfort (or resistance)

Opportunity to notice the ethics and values of social welfare. Potential to recognize something that you will want to cherish as a social worker.

3 Reassessing values

Think again about your own perceptions and social conventions.

4 Sow many seeds
