The need for evaluation education in welfare graduate schools

Social welfare represents...

•the value of aiming for a better society where people can live happily

•the policies, systems, and practices to achieve that goal. = Social work

Global Definition of the Social Work Profession (IASSW & IFSW, 2014)

Global Standards for Social Work Education and Training (IASSW & IFSW)

• some of 30 core curricula of the standard focused on macro-practice.

The need for evaluation education in welfare graduate schools

Evidence-based practices (EBPs)

- scientist-practitioner model
- •5-steps: Ask, Acquire, Appraise, Apply, and Assess/Audit

Guidelines for Curriculum and Educational Systems in Graduate Schools of Social Welfare (Japan)

- Requires macro-practice competency and practical research skills. Therefore...
- "research methodologies for program development"
- "research methodologies for development, formative evaluation, dissemination for EBP"
- "methodologies for empowerment evaluation with stakeholder participation"

Japan College of Social Work (JCSW)

•welfare college established in 1946

•master's program was established in 1989/ the doctoral program in 1994.

"Welfare Program Evaluation Course" focuses on...

- program evaluation by Rossi et al.
- the educational content address EBP, macro -practice social work, effective program development and restructuring, continuous improvement and formative evaluation, and implementation and dissemination.

Evaluation: achievement

Numbers of students who complete the course

•Master's course: 41 (35% of graduates), Doctoral course: 6 (13% of graduates)

Now, the graduates...

engage in evaluation practice.

- engage in welfare education including evaluation as education and research positions at universities and graduate schools
- engage in research activities that utilize program evaluation

Practitioner/ Peer Based Empowerment Evaluation Research and training Center (PBEE-RC)

- based on the EBP Technical Support Center concept
- Collaborative researchers, graduate students, and graduate school graduates are also participating in this project

Evaluation: challenges

- Evaluation of this course itself is not carried out systematically yet.
- there are currently insufficient opportunities in Japan's social welfare field for students/ graduates to practice evaluation.
